IT IS HEREBY ORDERED as follows:


**I. Presumptive Fine Schedule**

**II. Overweight And Miscellaneous Violations**

The "2012 Schedule of Fines on Violations," attached hereto as Exhibit A, shall apply to all overweight and miscellaneous violations.
