IT IS HEREBY ORDERED as follows: that, in accordance with House Bill 2316, section 11 effective July 1, 2015:


Any party to a proceeding in this Court may arrange for audio-only recording or reporting of the proceeding by stenographic or other means. In order to arrange such recording, the party shall submit a Notice of Intent to Record Proceedings ("Notice") (see addendum) and identify therein the means of such recording prior to any recording taking place. Other than the method so identified, no other method of recording will be permitted without submission of a new Notice, which then will supersede and replace all prior notices. Submission of such notice shall excuse that party from compliance with order, otherwise prohibiting the use of recording devices, for the period of time during which the particular proceeding to which the Notice applies is being heard in court.

IT IS FURTHER ORDERED that, unless otherwise agreed between parties, any such recording shall be made at the sole expense of the party submitting the Notice. In no instance shall the Court incur any expense with relation to recording or facilitating such recording.

IT IS FURTHER ORDERED that, no recording or any part thereof may be used by any party during the proceedings.

IT IS FURTHER ORDERED that, no recording or any part thereof may be designated the official record of the proceeding.
